Preserving a legacy


- Ask uncomfortable questions (They did!)

- Listen to the dead!




PGMS: THEOLOGISE OR MOBILISE?



Is it a compelling story?

“By its very nature, mobilization demands the translation of complex field realities into simplistic slogans in order to rouse those who at first can only grasp basic concepts. In order to galvanize support and inspire commitment, the plight of the unreached must be presented with black and white clarity. The cookies have to be placed on a lower shelf.”



Is it the best story?

Winter expressed qualms about the phrase “unreached peoples”, writing in 1978*,

“I am convinced that the terminology *reached/unreached* is not very helpful.”




- It prioritised numbers of Christians over quality of church life
- Ignored wide spectrum of faith/belief/practice in favour of simple ‘in-out’ categories

Is it the story's ending?

“Reaching the peoples is merely the process whereby the realistically valid opportunity is created”.

Winter, ‘Unreached Peoples, the development of the concept’ in Conn, H., ed., *Reaching the Unreached: The Old-New Challenge*, Phillipsberg, NJ: Puritan and Reformed, 1984, 37-38.




Is there only one storyline?

“It became obvious that Winter felt the term “unreached peoples” began to be used as a synonym for larger ethnolinguistic groups instead of the sub-groups the 1982 definition intended (or he intended!).”




“Beware of taking ethnolinguistic lists too seriously”

Another reason to be cautious when applying people group thinking is the reality that powerful forces such as urbanization, migration, assimilation, and globalization are changing the composition and identity of people groups all the time. The complexities of the world's peoples cannot be neatly reduced to distinct, non-overlapping, bounded sets of individuals with permanent impermeable boundaries. Members of any community have complex relationships and may have multiple identities and allegiances. Those identities and allegiances are subject to change over time.





Learning from the legacy


- Acknowledge innovation and compassion
- Make wise and careful use of lists
- Best guesses are all we have – ‘Messiology’
- Obsession with % overlooks the 0.000017% of Jews who established the Church
- Managerial mission doesn't reflect well the divine extravagance of cross and resurrection as the divine rescue plan.
- Contemplate and validate other strategies of mobilisation
